A Councillor vacates office during a term of office if that Councillor-"f) was elected to represent a ward and who –

(ii) Was not nominated by a party as a candidate in the ward election and ceases to be a member of a party."

The Council **RESOLVED** to **NOTE** that Councillor L. May ceased to be a Councillor on the 8 July 2016.
