CIDB grading for (1-3) CE
- C. CV's of core people
- D. References of previous paving contracts
- E. Letter of good standing from the department of labour
- F. Tax Compliance Status Issued with a Pin
- G. Proof of registration on Makana Supply Database and Central Supplier Database (CSD)
- H. Proof of registration on Makana SMME database
- I. Proof of residency within Makana Municipality Area of Jurisdiction such as telephone account / bank statement.
- J. Completed and signed declaration of interest MBD 4, MBD 6.1, MBD 6.2, MBD 8 and MBD 9
- K. Original Certified B-BBEE Certificate
- L. Billing clearance certificate/ lease agreement/ statement of municipal accounts must be attached.
- M. Completed BOQ with rates for labour, tools and equipment, compliance to OHS/EMP requirements, any other costs involving TAX, Transport, mark-up etc.
