- Original certified copy of BBBEE Certificates issued by an authorized body or person or sworn affidavits as prescribed by the BBBEE Codes of Good Practice. Failure to do so will result in loss of points;
- Original certified copy Directors / Owners / Partners Identity documents;
- Municipal Billing clearance certificate, lease agreement signed by both parties the lessor and the lessee, if expired extension of the lease must be attached or statement of municipal accounts not more than 3 months in arrears and must not be more than 3 months old, must be attached to and be returned with the tender documents, Failure to submit will result in disqualification;
- Tenderers must be registered as a supplier/service provider on Makana Local Municipality supplier/service provider database and Central Supplier Database (CSD) - proof of registration (Makana Database Confirmation Letter; CSD Registration report) on both databases, must be submitted;
- Tenders which are late, incomplete, unsigned or submitted by fax or electronically, will not be accepted;

- Documents to be filled with non-erasable black ink,
- Tenders submitted are to hold good for a period of 90 days.

Received Responsive proposals will be evaluated based on the following two stages, namely:

- Stage 1 – Functionality
- Stage 2 – Price and Preferential Points

A bidder that scores less than 70 points out of 100 in respect of "functionality" will be regarded as submitting a non-responsive bid and will be disqualified and will be not evaluated further, i.e. for price. Only bidders who score 70 points or more would be evaluated further and therefore eligible for the award.
