

PUBLIC NOTICE

Reference is made to a notice that was issued in November 2022 informing Makana Municipality residents about a comprehensive indigent registration campaign to update indigent register. The registration process started on **22 November 2022** and ended on 8th of **March 2023** and all wards were visited.

It is important to note that application does not mean automatic registration as there are strict verification processes which also entails a home visit. It is then important that applicants supply and submit correct information and documentation during the application and verification process.

Only once the indigent coordinator from the municipality declares that the household qualifies as an indigent, will the application be approved. Indigent households are re-evaluated within a period of a year (12 months) after being declared an indigent household. To ensure there is no break in your indigent status, visit your nearest Indigent Office at least six months before indigent status expires to reapply, as indigent subsidy is terminated on the 30 June each financial year.

Indigent households receive basic services for free, and it is important to know what is offered and how to put it to good use. In the current financial year (2023/24) the following applies:

- Free refuse removal -R143.50
- First **50 kWh** of electricity per month is free. – R150. 00
- First **6kl** of water – R80.64
- Monthly sewer charges – R215.25

It is important that indigent households are aware that once they exceed the free services offered, they are responsible for payment thereof. Failure to pay will result in the suspension of municipal services. It is further important to note that in the revised indigent policy the consumer is liable to pay for property rates as they are not subsidies by National Treasury.

All those who missed the opportunity in this current financial year are encouraged to visit the Finance department for registration in November 2023.

OPENBARE KENNISGEWING

Daar word verwys na 'n kennisgewing wat in November 2022 uitgereik is om Makana Munisipaliteit se inwoners in te lig oor 'n omvattende hulpbehoewende registrasieveldtog om die Behoefte Register op te dateer. Die registrasieproses het op 22 November 2022 begin en op 8 Maart 2023 geëindig en alle wyke is besoek.

Dit is belangrik om daarop te let dat die voltooi van 'n aansoek nie outomatiese registrasie beteken nie aangesien daar streng verifikasieprosesse is, wat ook 'n huisbesoek behels. Dit is dan belangrik dat aansoekers korrekte inligting en dokumentasie tydens die aansoek- en verifikasieproses verskaf en indien.

Eers sodra die hulpbehoewende koördineerder van die munisipaliteit verklaar dat die huishouding as 'n behoefte kwalifiseer, sal die aansoek goedgekeur word. Behoefte huishoudings word binne 'n tydperk van 'n jaar (12 maande) herwaardeer nadat hulle as 'n behoefte huishouding verklaar is. Om te verseker dat daar geen onderbreking in jou behoefte status is nie, besoek jou naaste Behoefte Kantoor ten minste ses maande voor jou behoefte status verval om weer aansoek te doen, aangesien die hulpbehoewende subsidie op 30 Junie elke finansiële jaar beëindig word.

Behoefte huishoudings ontvang basiese dienste gratis, en dit is belangrik om te weet wat aangebied word en hoe om dit goed te benut. In die huidige finansiële jaar (2023/24) geld die volgende:

- Gratis vullisverwydering -R143.50
- Eerste 50 kWh elektrisiteit per maand is gratis. – R150. 00
- Eerste 6kl water – R80,64
- Maandelikse rioolkoste – R215,25

Dit is belangrik dat hulpbehoewende huishoudings bewus is dat sodra hulle die gratis dienste wat aangebied word oorskry, hulle verantwoordelik is vir die betaling daarvan. Versuim om te betaal sal lei tot die opskorting van munisipale dienste. Dit is verder belangrik om daarop te let dat in die hersiene Deernisbeleid, die verbruiker aanspreeklik is om vir Eiendomsbelasting te betaal aangesien dit nie gesubsidieer word deur die Nasionale Tesourie nie.

Almal wat die geleentheid in hierdie huidige finansiële jaar misgeloop het, word aangemoedig om die departement Finansies te besoek vir registrasie in November 2023

Kubhekiselwa kwisaziso esakhutshwa ngoNovemba ka-2022 esazisa abahlali bakaMasipala waseMakana malunga nephulo elibanzi lokubhalisa abangathathi ntweni ukuhlaziya irejista yabangathathi ntweni. Inkqubo yobhaliso yaqala nge-22 Novemba 2022 yaze yaphela nge-8 kaMatshi 2023 kwaye zonke iiwadi zatyelelwa.

Kubalulekile ukuqaphela ukuba isicelo asithethi ukubhalisa ngokuzenzekelayo njengoko kukho iinkqubo zokuqinisekisa ezingqongqo ezikwabandakanya utyelelo ekhaya. Kubalulekile ke ngoko ukuba abafaki-zicelo babonelele kwaye bangenise ulwazi oluchanekileyo kunye namaxwebhu ngexesha lesicelo kunye nenkqubo yokuqinisekisa.

Kuphela xa umququzeleli ongathathi ntweni osuka kumasipala ethe ikhaya lifanelekile ukuba lihlwempu, isicelo siyakuvunywa. Amakhaya angathathi ntweni aphinde avavanywe kwakhona kwisithuba sonyaka (iinyanga ezili-12) emva kokubhengezwa njengekhaya elingathathi ntweni. Ukuqinisekisa ukuba akukho khofu kwisimo sakho sobuhlwempu, tyelela iOfisi yabaHluphekileyo ekufuphi kuwe ubuncinane kwiinyanga ezintandathu phambi kokuba imeko yobuhlwempu iphelelwe ukuze ufake isicelo kwakhona, njengoko inkxaso-mali yabasweleyo iyapheliswa ngowama-30 kuJuni kunyaka-mali ngamnye.

Amakhaya ahlelekileyo afumana iinkonzo ezisisiseko simahla, kwaye kubalulekile ukwazi oko kubonelelwayo kunye nendlela yokuyisebenzisa kakuhle. Kulo nyaka-mali (2023/24) oku kulandelayo kusebenza:

- Ukuthuthwa kwenkunkuma simahla -R143.50
- I-50kWh yokuqala yombane ngenyanga isimahla. -R150.00
- I-6kl yokuqala yamanzi - i-R80.64
- Iintlawulo zenyanga zogutyulo lwelindle - R215.25

Kubalulekile ukuba amakhaya angathathi ntweni aqonde ukuba xa athe agqitha kwiinkonzo zasimahla ezibonelelwayo, anoxanduva lokuzihlawula. Ukungaphumeleli ukuhlawula kuya kubangela ukunqunyanyiswa kweenkonzo zikamasipala. Kwakhona kubalulekile ukuqaphela ukuba kumgaqo-nkqubo wabasweleyo ohlaziyiweyo umboleki unoxanduva lokuhlawulela iirhafu zepropati njengoko ingeyiyo inkxaso-mali nguNondyebo weSizwe.

Bonke abo bathe baphoswa lithuba kulo nyaka-mali umiyo bayakhuthazwa ukuba batyelele isebe lezeMali ukuze babhalise ngoNovemba ka-2023.
