PUBLIC NOTICE AMNESTY FOR ILLEGAL CONNECTIONS

Makana Municipality is now offering customers who have tampered with their electricity and water meters the opportunity to normalize their meters without penalty.

The amnesty period ends on the 8th of December 2023. Once the customer reports the unauthorized connection, municipal technicians will assist with normalizing of the meter. After the amnesty period customers found to have falsified meters will be responsible.

Accordingly, there will be no mercy for those who illegally connect to the municipal network and such actions will be subject to a Council approved penalty of a minimum of R 7,445.87 plus VAT and assessed loss.

Consumers are requested not to tolerate any meter tampering by a municipal representative or any other person claiming to be a municipal representative as the Council will impose penalties against consumer account. Hence the request that all consumers who are not sure about the state of the meter to come forward.

Makana Munisipaliteit bied nou aan kliënte wat met hul elektrisiteit- en watermeters gepeuter het die geleentheid om hul meters sonder boete te normaliseer.

Die amnestietydperk eindig op die 8de Desember 2023. Sodra die kliënt die ongemagtigde verbinding aanmeld, sal munisipale tegnici help met die normalisering van die meter. Na die amnestietydperk sal kliënte wat bevind word dat hulle meters vervals het, sal verantwoordelik gehou word vir enige koste aan gepeuter was,

Gevolgtlik sal daar geen genade wees vir diegene wat onwettig aan die munisipale netwerk koppel nie en sulke optrede sal onderhewig wees aan 'n Raad-goedgekeurde boete van 'n minimum van R 7,445.87 plus BTW en aangeslane verlies.

Verbruikers word versoek om geen meterpeutery deur 'n munisipale verteenwoordiger of enige ander persoon wat beweer dat hy 'n munisipale verteenwoordiger is te duld nie, aangesien die Raad boetes teen verbruikersrekening sal oplê. Vandaar die versoek dat alle verbruikers wat nie seker is oor die toestand van die meter nie, na vore moet kom.
