

PUBLIC NOTICE CALLING FOR COMMENTS ON AMENDMENT TO WATER TARIFF STRUCTURE DURING DROUGHT PERIODS.

Notice is hereby given in terms of section 21A of the Local Government: Municipal Systems Act, 2000 (Act No.32 of 2000) as amended, herein after referred to as the "Act", that Makana Municipality approved an amendment to the Water Tariff Structure for Drought periods effective from the financial year 2019/20 commencing on 01 July 2019 and is open for public inspection in the designated areas of the Municipality as mentioned hereunder. A more punitive tariff structure is necessary to ensure water usage is reduced to prolong the current water supply to our Residents. Makana Municipality has commenced with water meter readings to ensure that estimations are minimised and residents are not penalised for incorrect estimations. The Water Tariff Structure is reflected below and will be open for comments for the period from 24 May 2019 to 18 June 2019 and can be inspected during office hours between 08:00 to 16:00 from Monday to Thursday and 08:00 to 15:00 on Friday.
