Having heard Adv. Morgan, Counsel for the Applicant and having read the Notice of Motion and other documents filed of record

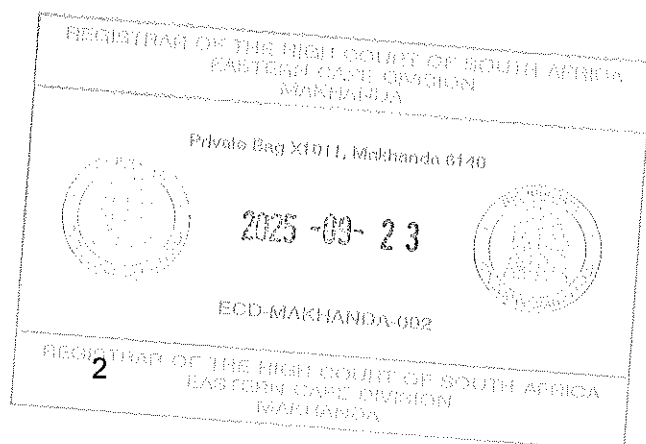
IT IS ORDERED THAT:

1. Paragraph 5 of the Order 4 September 2025 be and is hereby amended to read as follows:

“That the Applicant is directed to serve a copy of this Order upon the Third to Eleventh Respondents via their Facebook pages and such service shall be accepted as valid personal service upon the Third to Eleventh Respondents.”

2. The rule nisi be and is hereby confirmed in the following terms:

2.1 The Third to Eleventh Respondents are found to be in contempt of the Interim Order of the Honourable Justice Govindjee, dated 29 July 2025, which was confirmed by the Honourable Justice Laing, dated 26 August 2025, under case number: 2025-125869 (the “Court Orders”);



2.2 The consideration of any sanction to be imposed upon the Third to Eleventh Respondents be postponed sine die and the Applicant is hereby granted leave supplement its papers and to set the matter down for urgent consideration by this Honourable Court in the event that the Third and Eleventh Respondents further act, either directly or indirectly, in violation of the Court Orders;

2.3 The Applicant is authorised to demolish and remove any unauthorized structures erected on the property known as Erf 4807 in the Township of Grahamstown, Eastern Cape Province (the "Golf Course") by the Respondents and/or any other person;

2.4 The Respondents and/or any other person under the Respondents' direction are ordered to immediately cease and desist from engaging in any form of public violence in the jurisdiction of the Makanda Municipality;

2.5 The Respondents and/or any other person under the Respondents' direction are ordered to immediately cease and desist from causing damage to any building and/or property of the Makhanda Municipality or any other building or property in the jurisdiction of the Makhanda Municipality.



2.6 The Respondents and/or any other person under the Respondents direction are ordered to immediately cease and desist from threatening officials employed by the Makhanda Municipality.
